New Resolution Adopted

The Board of Directors have adopted Policy Resolution No. 25-01 Personal Articles on the General Common Elements. This expands the existing bylaws that no items are allowed on the general common elements.

This resolution clarifies the rules regarding the placement of personal articles such as decorations, bicycles, toys, sporting equipment, and other items on the community's common areas. The purpose of this resolution is to ensure the proper upkeep and maintenance of our shared spaces while maintaining a safe and attractive environment for all residents.

A key component to this resolution addresses when and where outdoor decorations are permitted. Decorations such as signs wreaths, flags, and seasonal displays may be placed on the mulched and grassy areas immediately outside the front door of a unit only from October 1st through January 31st.

Parking Lot Paving Scheduled

Starting September 9th the Mews will have all parking lots sealed and repainted. Please be sure to move your car to the street during your designated time.

The work will begin at 7:00 AM each day. All affected areas will be closed and will reopen the following day once striping is complete.

Resident Instructions

- Vehicle Removal: All vehicles must be removed from the specified courts no later than 6:30 AM on the scheduled service date. It is recommended to move your vehicle the night before.
- No Water Usage: Please refrain from watering lawns, washing cars, or allowing any water to run onto the pavement for two days before and two days after the scheduled work.
- Stay Off Surface: Do not walk on wet or recently seal-coated areas until the contractor removes all traffic cones and caution tape. The surface requires adequate time to dry and cure.

Alternate Arrangements: Please make other arrangements for commuting, deliveries, or other services during these dates.

Towing Warning

Any vehicles remaining in the designated work areas after 6:30 AM on the scheduled day will be towed at the sole risk and expense of the vehicle owner.

Rain Date Policy

If work is canceled due to weather, a notice will be sent out by NRP on the scheduled morning. A new date will be scheduled for the canceled portion. Please be aware that a rain out on one day will not affect the rest of the week's schedule. For example, if the work on September 9th is canceled, the work for September 11th will proceed as planned.

Neighborhood Reminders



RECYCLING

On Tuesday evening or Wednesday morning, residents may place the following items in the recycling bins left at each court:

- Aluminum and other metal cans
- Plastic containers
- Paper
- NO GLASS

These items should be rinsed prior to being placed in the bins. No plastic bags should be placed in the bins.

Mixed paper and cardboard can also be recycled in the blue bin or in a paper bag. Cardboard boxes must be broken down and flattened. These items should be left next to the bins.

PETS

- Cats are not be allowed to roam freely.
- All dogs must be leashed pursuant to Arlington County law.
- · Owners must clean up after their dogs.
- No pets are allowed on the tennis courts at any time.
- Keep pets away from flowerbeds and border plantings.
- Do not allow dogs to bark excessively or leave barking dogs unattended on your patio.
- The pet exercise area at the end of 36th street is for LEASHED dogs only.

PARKING RULES



- Each unit is assigned one parking space.
- Park only in your designated space or your vehicle may be towed.
- Visitors must park on the street unless using a specially designated visitor parking space.
- Call the posted telephone numbers to request towing or if your vehicle was towed.
- Please do not use visitor spaces as your personal second parking space and share with the community.

TRASH COLLECTION



- Trash is collected six days a week,

 Monday through Saturday.
- Please put trash out by 8 a.m., but not the night before.
- Large items are collected on the first Saturday of each month.



COMMON SPACE

- Please do not hang swings (or anything) from our trees
- Strollers, toys, and bicycles may not be stored on front stoops
- Do not allow anyone to draw on our tennis courts with chalk
- Clean up after yourselves by the playground and area outside of the tennis/basketball court
- Only one small personal item per unit may be on the mulch or grass during landscaping season so that mowing, weeding, and trimming is not impacted.
